# TABOR COLLEGE-HILLSBORO COLLEGE LEVEL EXAMINATION PROGRAM (CLEP)

## **Objective**

The College Level Examination Program provides people of all ages and backgrounds an opportunity to demonstrate college-level proficiency on the basis of examinations designed to reflect college course curriculums. Tabor College believes that those deserving credit should receive it and therefore has established a policy that rewards and encourages self-motivated learning.

#### **Cost and Registration**

Tabor does not charge any fee for granting the credit but there is a fee for taking the exam. The tests may be taken at any convenient test center. Information about test centers, exams and fees can be found at <a href="https://clep.collegeboard.org">https://clep.collegeboard.org</a>. Students should contact the testing center of their choice for testing dates and for registration information.

### **Granting of Credit**

The maximum amount of credit by examination which may be applied to the 120 semester hours required for the completion of a Bachelor's Degree is 30 hours. The maximum amount of credit that can be given for nontraditional hours, which includes credit by examination and portfolio hours, is 45 hours.

Credit by CLEP exam will be graded "Credit" and will not be computed into the student's GPA. Non-graded CLEP credit will not be counted against the student's credit/no credit limit.

CLEP credit will be identified on the transcript as credit received through CLEP examinations.

CLEP exams may not be used to replace grades earned in residence.

Students need to submit a copy of their score reports so they can be evaluated according to our CLEP policy for both the minimum score and the amount of credit given

The following list gives the name of the exam, the score required, credit given, and equivalency to Tabor courses.

CLEP subject exams correspond to particular Tabor courses. They may be treated as prerequisites for subsequent courses. A student may not receive credit by examination in a course if more advanced work has been taken in that subject.
